Waiver and Release and Assumption of Risk Agreement

In consideration of my participation in any USFSA, ISI, EPHA and/or Sun City Blades Figure Skating Club ("SCBFSC") sponsored activity, I acknowledge that:

1. I understand the risks and dangers inherent in skating in general and in the activities of the SCBFSC, ISI, EPHA, and USFSA, and believe I (or the minor that I represent as parent/guardian) am/is qualified, in good health, and in proper physical condition to participate in such activities. I further acknowledge that if at any time I believe conditions are unsafe, I (or minor I represent) will discontinue participation.
2. I fully understand that skating and the activities of the SCBFSC, USFSA, EPHA, and ISI involve risks of serious bodily injury, including permanent disability, paralysis and death. These risks and dangers can be caused by my own actions (or inactions), by the actions (or inactions) of others participating in the activity/event, the condition(s) in which the activity/event takes place, or the negligence of the releasees named below. There may also be other risks not known to me (or the minor I represent) or foreseen at this time, and I fully accept and assume all such risks and all responsibility for losses, costs, and damages that I (or minor I represent) incur as a result of my/our participation in the activity.
3. I, individually and on behalf of all minors I represent, hereby release, discharge, covenant not to sue, and hold harmless SCBFSC, EPHA, USFSA, ISI, its Member Clubs, and their respective administrators, directors, agents, officers, volunteers and employees, other participants, sponsors, advertisers, and owners and lessors of premises on which a USFSA, ISI, EPHA and/or SCBFSC sanctioned activity/event that I (or the minor child I represent) participate in takes place (collectively, "releasees") from all liability, claims, demands, losses, causes of action or damages arising out of the gross negligence of, or intentional, willful, or wanton misconduct of the releasees herein. If I, or anyone on my behalf/or my minor child's behalf, make(s) a claim that does not arise from the gross negligence of, or intentional, willful, or wanton misconduct of the releasees herein, I will indemnify, defend, save, and hold harmless each of the releasees from any loss, liability, damage, or cost any may be incurred as a result of such claim.

I have read the agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and have signed it freely and without any inducement or assurance of any nature. I intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law, and agree that, if any portion of this Waiver and Release and Assumption of Risk Agreement is held by a court of competent jurisdiction to be invalid or unenforceable, the balance notwithstanding shall continue in full force and effect.
